  - 3. **THAT** I have analyzed the declaration of the Presidential results by the Chairperson of the Independent Electoral and Boundaries Commission (IEBC) vis a vis the Form 34Cs

- and has thus discovered startling anomalies in the aforesaid declaration as deponed hereunder.
- 4. **THAT** the actual summation of the total valid votes from the IEBC portal is **15,179,717**.
- 5. **THAT** the actual summations shows that Raila Odinga has **6,821,505** votes while Uhuru Kenyatta has **8,222,861** votes, and the Total rejected votes as per the IEBC portal amounts to **477,195** votes.
- 6. **THAT** the IEBC portal displays the summations as follows; the total valid votes are **15,180,381**, Raila Odinga's votes amounts to **6,821,877** while Uhuru Kenyatta's votes are at **8,223,163** and the Total rejected votes amounts to **403,495**.
- 7. **THAT** the declaration of results for the election of the President at the National Tallying Centre as per the Form 34C is as follows; the total valid votes are **15, 114,622**, Raila Odinga **6,762,224**, Uhuru Kenyatta **8,203,290** and the total rejected votes amounts to **81,685** votes.
- 8. **THAT** the actual variation of rejected votes between the actual summation of results and those displayed at the IEBC portal amounts to **73,700** votes.
